B. Skyworx Drone Shows Agreement for End of Summer Bash Event (Not to Exceed \$33,500)

Objective: Provide Elgin residents and visitors with the return of a crowd-pleasing drone show.

- C. Commissioned Work of Art Agreement with Eric Dowdle (Not to Exceed \$120,000)
 - Objective: Create original artwork of Elgin cityscape featuring local foods and customs and the interesting people that work and live in these places that is later transformed into limited-edition puzzles and giclées, allowing collectors to connect and bond with the artwork in multiple ways.
- **D.** Redevelopment Agreement with TriEss LLC and Side Street Studio Arts, NFP (\$500,000) Objective: Enter into a redevelopment agreement to induce the first phase of the renovation and adaptive reuse of the three-story building at 62 South Grove Avenue for art programming, exhibitions, events and classes.

E. Juvenile Violence Intervention and Prevention—Youth Empowerment Program (\$45,600)

Objective: Contract with community liaisons to provide administrative duties inclusive of home visits, school visits, and other programs while working in conjunction with the police department and community partners for the juvenile violence intervention and prevention Youth Empowerment Program.
